OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING.

- 1. **CONTEST DESCRIPTION:** Bloomington Convention & Visitors Bureau's #BLOOMINGTONWINTER CONTEST (the "Contest") is sponsored by the Bloomington Convention & Visitors Bureau located at 2131 Lindau Lane, Suite 420, Bloomington, MN 55425, USA (the "Sponsor"). This contest is in no way sponsored, endorsed or administered by, or associated with Instagram.
- 2. **ELIGIBILITY:** The Contest is open to individual persons who are at least eighteen (18) years old at the time of entry, who are legal residents of the United States and who are not otherwise prohibited from participating in the Contest as provided in these Official Rules (the "Entrants"). The Contest is subject to all applicable local, state, and federal laws and regulations, and is void outside the United States and where otherwise prohibited or restricted by law. Any employees, officers, directors, or representatives of the Sponsor (including its divisions, subsidiaries, affiliates, and advertising or promotional agencies) or suppliers (including their respective divisions, subsidiaries, affiliates, and advertising or promotional agencies) providing the Prize or other materials or services in connection with the Contest or any person acting in an official capacity for or on behalf of any governmental entity or organization, branch of any government, government department or agency, or political party (whether local, state, or federal), including, but not limited to, a government-owned or controlled company, and the immediate family members (defined as parents, spouses, children, siblings, grandparents, and their respective spouses) or members of the same household (whether or not related) of any of the foregoing are not eligible to enter the Contest or win the Prize.

Option 2: Upload your image to our collector link found on https://www.bloomingtonmn.org/promo/bloomington-social-contest and follow the prompts.

All entries must be in the English language. Incomplete entries are void. Proof of entry will not be deemed proof of receipt by the Sponsor. Only one (1) entry per person per image post per day will be accepted during the Contest Period. For purposes of these Official Rules, a "day" is defined as any time period during the Contest Period beginning each day at 12:00 a.m. CT and ending each day at 11:59 p.m. CT. Entries received in excess of the stated limitation will be void. The Sponsor will not accept entries by phone, mail, email, fax, or any other method not specifically permitted herein or if not received during the Contest Period.

- 4. **SELECTION OF PRIZE WINNER(S):** On or about March 3, 2023, one (1) potential prize winner will be selected from among all eligible entries received during the Contest Period. In order to be declared a winner by the Sponsor, the potential winner must be in compliance with these Official Rules and, in particular, the following:
- a. A representative of the Sponsor must be able to reach the potential winner independently by direct message (DM) informing him/her that he/she is the potential winner subject to complying with the Official Rules. The potential winner is required to respond to the DM notification within a forty-eight (48) hour period of the sending of the DM. - In the event of a conflict between these Official Rules and any instructions or interpretation of these Official Rules given by an employee of the Sponsor, these Official Rules shall govern and control. In the event of a conflict between these Official Rules and disclosures or other statements contained in any Contest-related materials, including, but not limited to, the Contest entry form, Contest Website, or print or online advertising, these Official Rules shall govern and control. By entering this Contest, the Entrants agree to be bound by and accept these Official Rules and the decisions of the Sponsor (including, but not limited to, decisions regarding eligibility of entries, the selection of the winner, and the awarding of the Prize), which are final and binding in all respects. The Sponsor may amend these Official Rules at any time without notice to or the consent of the Entrants. Under no circumstances shall the Released Parties' aggregate liability to any Entrant of the Contest exceed One Dollar (US \$1.00).
